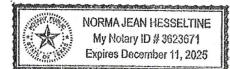

## **EXHIBIT "A"**

BEING a 2.351 acre tract situated in the George W. Brooks Survey, Abstract Number 4, Hardin County, Texas, being a portion of the remainder of that certain called 144.24 acre tract described as "Tract One" in instrument to Thomberry Oil Field Services, Inc., recorded in Volume 1728, Page 416, of the Official Public Records of Hardin County, Texas (O.P.R.H.C.T.), said 2.351 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2 inch iron rod with cap stamped "TPS 100834-00" set in the Easterly mergin of Farm to Market Road 2937 (FM2937), for the common Westerly corner of said remainder of 144.24 acre tract and that certain called 3.59 acre tract described in instrument to Johnnie Lynn Gore, recorded in Volume 1331, Page 445, O.P.R.H.C.T., being the Northwesterly corner of the herein described 2.351 acre tract.

THENCE North 86° 17' 36" East, 325.48 feet, with the common line between said remainder of 144.24 acre tract and said 3.59 acre tract to a 1 inch iron pipe found in the Westerly line of that certain called 25 acre tract described in instrument to J. C. Dodson and Gloria Dodson, recorded in Volume 1105, Page 684, O.P.R.H.C.T., for the common Easterly corner of said remainder of 144.24 acre tract and said 3.59 acre tract, being the Northeasterly corner of the herein described 2.351 acre tract.

THENCE South 03° 30' 59" East, 451.40 feet, with the Westerly line of said 25 acre tract and that certain called 10 acre tract described in instrument to Melissa Crane, recorded under Instrument Number 2012-29828, O.P.R.H.C.T., common to the Easterly line of said remainder of 144.24 acre tract to a 1/2 inch iron rod with cap stamped "TPS 100834-00" set for the Southeasterly comer of the herein described 2.351 acre tract, from which a 4 inch by 4 inch concrete monument with disk found for a common corner of said remainder of 144.24 acre tract and said 10 acre tract bears South 03° 30' 58" East 697.47 feet.
