### ORDER ADOPTING 2022 TAX RATE

**WHEREAS**, on this the 23<sup>rd</sup> day of August, 2022, came on to be considered for adoption the 2022 tax rate of Hardin County, Texas, by the Hardin County Commissioners Court. The following Members were present:

**WHEREAS**, upon motion made by Commissioner L.W. Cooper, Jr., Precinct No. 1, and second by Commissioner Alvin Roberts Precinct No. 4, it is hereby ORDERED that the Tax Rate for the 2022 Tax Year shall be adopted and set as follows:

- (1) the debt service tax rate is hereby set at \$0.008322 per \$100 valuation
- (2) the maintenance and operation tax rate is hereby set at \$0.532513 per \$100 valuation
- (3) the total tax rate is hereby set at **\$0.540835** per \$100 valuation


This total Tax Rate is lower than the rate set for the 2021 Tax Year; and it is a 6.20% increase over the No-New Revenue Tax Rate of \$0.509266 per \$100 valuation.


THIS TAX RATE WILL RAISE LESS TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE MAINTENANCE AND OPERATIONS TAX RATE WILL EFFECTIVELY BE RAISED OVER THE NO-NEW REVENUE MAINTENANCE AND OPERATIONS TAX RATE BY 4.78% AND WILL LOWER TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$15.41.






