



## *May 2019 – Hardin County Health Inspections*

- Dollar General – 2771 FM 92, Silsbee – doors not working correctly at the entrance, water faucet for public drinking is dirty and very unsanitary, no 3 compartment sinks to clean equipment – earned a score of 93
- Zip-In-Grocery – 15321 FM 418 E, Silsbee – behind ice chute @ fountain needs cleaning, 3 compartment sink filthy, storage area needs to be clean and organized, worms need to be on a bottom shelf away from other food and beverages, ice machine has slime, no employee restroom, place is not clean other than counter tops– earned a score of 77 – did revisit and most items were corrected.
- Subway – Walmart – 100 S. LHS Dr, Lumberton – all specifications met – earned a perfect score of 100
- Waffle House – 750 S. Main, Lumberton – all specifications met – earned a perfect score of 100
- Smoothie King – 104-A S. LHS Dr, Lumberton – all specifications met – earned a perfect score of 100
- Papa John’s – 209 S. Main, Lumberton –no cover on fluorescent lights, light in walk-in cooler needs replacing – earned a score of 99
- Mitchell Road Fish & Shrimp – very clean and organized - all specifications met – earned a perfect score of 100
- Juan’s Mexican Food – 1109 S. Main, Lumberton – all specifications met – earned a perfect score of 100
- Dollar General Plus – 42685 Hwy 105, Batson – all specifications met – earned a perfect score of 100
- Goodfella’s Pizzeria – 785 W. Hwy 105, Sour Lake – very clean and organized - all specifications met – earned a perfect score of 100
- Oiler Country Store – 42854 Hwy 105, Batson – remove broken equipment from service area, chest freezer door broken, reach-in needs cleaning inside and gaskets, employee drink on food prep counter, need Food Manager and Food Handler certificates, towels on counter top, no paper towels at hand sink, bulbs need cover over the fryer area, need lids on trash cans for customers, leaking faucet at 3 compartment sink, prep not labeled, kitchen door and threshold needs to be scrubbed, boxes on the floor by ice machine, area needs cleaning – earned a score of 84
- Jack-in-the-Box – 150 Hwy 327 E, Silsbee – some light bulbs need replacing, ceiling in dining area has moldy vents, cleanliness is an issue in BOH, Light cover needs to be fixed at drive-thru, ice buckets sitting on the ground, mop sitting on the floor, need to post permit, inspection report and one Food Manager Certificate, some items corrected on site – earned a score of 94
- Kountze Nursing Center – 604 FM 1293, Kountze - all specifications met – earned a perfect score of 100

- Honky Tonk Texas Grill – 2307 Hwy 96 N, Silsbee - all specifications met – earned a perfect score of 100
- Fire & Ice - Mobil Unit – 3109 FM 2798, Votaw - new food establishment - all specifications met – earned a perfect score of 100
- Dollar Tree – new opening – 360 Hwy 105 E, Sour Lake – Opening day and hot water not working – earned a score of 96
- Tejas #1 – 2142 Hwy 327 East, Silsbee – sour smell in ice machine area, wet boxes on the floor, dead roaches and towels on the floor, slime inside ice machine, restroom had no soap, paper towels or hot water, sink coming away from the wall, gnats at the hand sink, 3 compartment sink full of stuff, hand sink not stocked and no hot water, no Food Handlers Certificates, broken freezer sitting by beer cases, observed employee coming in from outside and not washing hands, these must be posted for customers to view: permit, inspection report and one Food Handler Certificate - earned a score of 74
