ORDER ADOPTING 2025 TAX RATE

WHEREAS, on this the 26th day of August, 2025, came on to be considered for adoption the 2025 tax rate of Hardin County, Texas, by the Hardin County Commissioners Court. The following Members were present:

WHEREAS, upon motion made by Commissioner L.W. Cooper, Jr., Precinct No. 1, and second by Commissioner Chris Kirkendall, Precinct No. 2, it is hereby ORDERED that the Tax Rate for the 2025 Tax Year shall be adopted and set as follows:

- (1) the debt service tax rate is hereby set at \$0.0042910 per \$100 valuation
- (2) the maintenance and operation tax rate is hereby set at \$0.492674 per \$100 valuation
- (3) the total tax rate is hereby set at \$0.496965 per \$100 valuation


This total Tax Rate is lower than the rate set for the 2024 Tax Year; and it is a 2.01% increase over the No-New Revenue Tax Rate of \$0.487183 per \$100 valuation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE MAINTENANCE AND OPERATIONS TAX RATE OF \$0.492674 WILL EFFECTIVELY BE HIGHER THAN THE NO-NEW REVENUE MAINTENANCE AND OPERATIONS TAX RATE OF \$0.489205 BY 0.71% AND WILL DECREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$4.11.
