

## October 2023 – Hardin County Health Inspections

- Village Creek Rehabilitation 705 North Main, Lumberton all employees working with the food shall have a food handler certificate if not holding a food manager certificate, hand washing sink pressure was inadequate for washing hands, some foods held in the cooler where past the 7 day use by date and were discarded, wiping cloths were not being held in a measured solution of sanitizer, can opener was found dirty, no food manager certificate was displayed on the wall - earned a score of 91
- Kids Kampus Daycare 7921 Beverly, Lumberton some foods held in the cooler had no 7 day use by date and were discarded, sponges may not be used, wiping cloths were not being held in a measured solution of sanitizer - earned a score of 97
- Spanish Trail Assisted Living 775 Hwy 96 S., Silsbee hot water demands did not consistently meet the required temperature, some foods held in the cooler had no 7 day use by date and were discarded, food temperature measuring device shall be provide and shall be calibrated to ensure measuring correct temperatures, wiping cloths were not being held in a measured sanitizer solution, cooler was leaking water earned a score of 92
- Met Early Head Start 1155 Hwy 327 East, Silsbee food temperature measuring device shall be provided and calibrated to measure correct temperatures, ware washing machine shall operate according to the manufacture's label on temperature and sanitizing, manual hand washing water shall maintain a temperature of a minimum of 110 degrees F., cardboard container holding cups or any cardboard must be kept 6 inches above the floor - earned a score of 95
- Met Early Head Start 153 Maplewood, Silsbee some foods held in the cooler had no 7 day use by date and were discarded, food temperature measuring device shall be calibrated to ensure measuring correct temperatures, manual hand washing water shall maintain a temperature of a minimum of 110 degrees F., wiping cloths were not being held in a measured sanitizer solution, earned a score of 93
- Met Head Start 1565 S. Pine St., Kountze ware washing machine shall operate according to the manufacture's label on temperature and sanitizing, wiping cloths were not being held in a measured sanitizer solution - earned a score of 97
- Kids Kampus 2.0 New Opening 1809 Hwy 96 S, Lumberton all specifications met earned a perfect score of 100
- Lumberton Seafood House 351 S. Main, Lumberton food on line not at temp added ice bags to help, tossed all tartar sauce sitting out all day, employees not washing hands prior to putting on gloves, spray bottles not labeled, medicine bottle near food area, reach-in cooler not maintaining temp, no labels on foods in coolers, no sanitizer test strips, towels on the counter and not in sanitizer buckets, boxes on the ground need to be 6" off the ground, food not covered in WIC, bulk containers not labeled and had

scoops inside the container, cleaning opportunities in the kitchen area, lids not closed on dumpster, floors have some holes in concrete and need to be filled – holding water and FRP needs to have rubber coving to the floor, area leading to the WIC needs to be sealed-has gaps and open air, needs a covered trash can in women's restroom, no CFM posted, no inspection report posted, records for employees must be kept in house - earned a score of 74 – most items were corrected on site

- The Pine Knot Café New Opening 27272 FM 787, Thicket all specifications met earned a perfect score of 100
- Little Mexico 134 Pine Plaza, Silsbee food not dated in coolers, using prep sink to wash hands instead of dedicated HW sink, one employee did not have a hat on – earned a score of 95
- Family Dollar 118 Pine Plaza, Silsbee all specifications met earned a perfect score of 100
- Mi Pueblo 980 Hwy 327 East, Silsbee no CFM on duty, bulk containers not labeled and had scoops inside, must have inspection report posted, must have CFM certificate posted – earned a score of 96
- Short Stop 4345 Hwy 96 North, Silsbee food not marked for time and temperature control, equipment counters need to be cleaned and sanitized and can't have personal items there, person in charge is not a CFM and lacks knowledge in the kitchen, hand sink not being used, no CFM on duty, no dates on foods, no sanitizer buckets- towels on counters and dirty towels need to be removed from kitchen area, boxes on floor in kitchen and storage, food being thawed in the sink without running water, walls dirty and rugs need sweeping, mops must be hung and not left on the ground earned a score of 76 some items corrected on site
- Little Palermo 3542 Hwy 96 North, Silsbee chemical containers not labeled, food handler expired – earned a score of 95
- Juan's Mexican Restaurant 1109 South Main, Lumberton all specifications met earned a perfect score of 100
- Aloha Shaved Ice 275 Hwy 96 South, Silsbee all specifications met earned a perfect score of 100
