

April 2023 – Hardin County Health Inspections

- Starbucks Coffee 121 South LHS Dr., Lumberton prep cooler containing milk, milk products & juices out of temperature @ 54 degrees, products measured 47-52 degrees, all coolers shall have thermometers inside located in a place that is easily readable & to be monitored – earned a score of 95
- Cowboy Cool Concessions MFU (new to our area) 5120 Hwy 326 N., Kountze serving snow cones, manufactured wrapped candy and bottled drinks - all specifications met – earned a perfect score of 100
- Smoke N Grocery 1160 N. 5th St., Silsbee no hot water in the store for service sink or hand washing sink earned a score of 96
- Tobacco Barn # 29 333 S. 5th St., Silsbee all specifications met earned a perfect score of 100
- Silsbee Shell 210 Hwy 96 S., Silsbee ice machine was closed for cleaning of slime and accumulated particles, ice scoop laying in service sink asked store to clean, sanitize and place in a clean container with handle up, employees did not hold a food handler certificate, thermometer to be placed in the reach in cooler holding food – earned a score of 93
- Subway in Walmart 100 N. LHS Dr., Lumberton no hot water at the hand sink located in prep area is not conveniently accessible earned a score of 98
- HEB 819 North Main, Lumberton all specifications met earned a perfect score of 100
- Crazy Jose's 951 South Main, Lumberton food in WIC not labeled, sinks designated for handwashing must only be used for handwashing, cleaning opportunities for shelves by ice machine, employee drinks, food and personal items cannot be on work surfaces, bulk containers not labeled, shelves need cleaning, light bulbs out above the grill area – earned a score of 89
- Walmart 100 N LHS Dr., Lumberton need internal thermometers for WIC's, no paper towels by deli hand sink, wall by mop sink area needs cleaning- all corrected on site – earned a score of 95
- Wendy's 518 S Main, Lumberton hot water for hand washing was not at the proper temperature (was 72 degrees) earned a score of 98
- Brookshire Brothers 421 S Main, Lumberton some thermometers missing or not working in coolers, ceiling tiles need replacing in the back storage area, permit, food manager certificate and inspection report must be stored in a conspicuous location for customers to view - earned a score of 96
- Hwy 96 Truck Stop 5008 Hwy 96, Silsbee ice buckets sitting on the ground, counter surfaces were cluttered with paperwork and personal items, need the well testing information, no CFM on duty, no food handlers for staff, no thermometers in hot or cold

units, employees wearing jewelry on their arms when prepping food, no hair restraints upon arrival, no sanitizer buckets being used for towels, boxes not 6" off the ground, bulb out at vent-a-hood and no protective cover over other bulb, fire extinguisher and ansul system need inspections, no records for water well, certificates for employees not on premises - earned a score of 80

- Speedy Stop 755 S Main, Lumberton all specifications met earned a perfect score of 100
- Tejas #5 3322 FM 92, Silsbee cold-hold island was not in temperature-pulled all TCS foods, no thermometer for hot foods, raw chicken over diced onions in WIC, workers without a food handler certificate, food in zip lock bags not labeled in freezer, no thermometer available to take temps of foods, dish room hand sink missing soap and paper towels, tape on top of counter top where food is prepared-must remove, saw a live roach in the deli area, no sanitizer buckets out for towels, lid on dumpster must stay closed, trash can foot pedal broken and needs to be replaced, no first aid kit earned a score of 77
- Chili's Grill & Bar 1010 Hwy 96 South, Silsbee ice scoop left in ice bin, all spray bottles must be labeled, saw a roach in the restroom, hair must be pulled back and beard guards must be worn in food prep area earned a score of 91
- Cowboy Cool Concessions MFU all specifications met earned a perfect score of 100
- Wing Junkiez MFU need test strips for sanitizer, knob on cold water missing and no paper towels at the hand sink, need a first aid kit – earned a score of 94
- Tiff & E's Orange Box MFU all specifications met earned a perfect score of 100
- Terrell's Ice Cream MFU all specifications met earned a perfect score of 100
- JR Foodmart 1240 N 5th Street, Silsbee no test strips for sanitizer, food surfaces not cleaned or sanitized as needed or every 4 hours, all wood shelving must have a wipeable cleanable surface, no sanitizer buckets for towels, fly bait must be put in an area not near food, thawing food improperly, all boxes must be 6" off the ground, doors, gaskets and walls need cleaning, fluorescent bulbs need protective covers, ceiling tiles need replacing and fans need cleaning, must have a trash can with a lid for the ladies restroom earned a score of 82
- Blue Jug of Lumberton **NEW** 700 N. Main, Lumberton all specifications met earned a perfect score of 100
- Fire House Subs 301 N. LHS Dr. Ste.100, Lumberton all specifications met earned a perfect score of 100
- Days Inn 131 N. LHS Dr., Lumberton all specifications met earned a perfect score of 100
- Uptown Nutrition 42491 Hwy 105, Batson all specifications met earned a perfect score of 100
- Family Dollar Store 9343 2nd Street, Batson all specifications met earned a perfect score of 100
- For the Love of Foods NEW 700 N. Main, Lumberton no hair coverings being worn, no test strips for sanitizer – earned a score of 97

- La Quinta 104 N. LHS Dr., Lumberton no certified food manager on shift and not posted for consumers to view earned a score of 97
- Subway 104 S. LHS Dr., Lumberton no hot water at hand sink, missing food handler certificates earned a score of 97
- Tejas Exxon #7 200 S. Pine Street, Kountze no food handler certificate, missing dates on food, need a mop sink, missing thermometers in coolers earned a score of 92
- Daily Cream Donuts 42494 Hwy 105, Batson no food manager certificate and not posted in view for customers, missing thermometers in coolers earned a score of 95
