



June 2025 – Hardin County Health Inspections

- Sonic - 106 N Main, Lumberton, TX – Earned a score of 98 - Hot hold equipment had a buildup of food crumbs.
- Sonic - 370 E. Hwy 105, Sour Lake, TX – Earned a score of 99 - Roach was found on the lip of ice machine alive.
- Domino's - 1330 N. 5th St., Silsbee, TX - All specifications met- Earned a perfect score of 100.
- Little Mexico – 134 Pine Plaza, Silsbee, TX – Earned a score of 99 - Tongs laying inside chip container.
- Fresh Start – 125 N. 5th St., Silsbee – all specifications were met – earned a perfect score of 100
- Subway – 1005 Hwy 96 Bypass Ste. 1017, Silsbee – all specifications were met – earned a perfect score of 100
- Subway – 760 Hwy 96 S., Silsbee – all specifications were met - earned a perfect score of 100
- Tejas #4 – 770 South Pine, Kountze – a clean & designated sink for wash, rinse, sanitizing & an area designated for air drying of utensils such as - coffee pots, drink nozzles, ice shoots & cleaning of counters was not available, employees on duty did not have a food handler certification, unnecessary items such as gas cans, oily rags & clutter were in the self-serve drink areas, most recent health inspection report or sign posting report is available upon customer request was not posted for customer view - earned a score of 90
- Champion Ranch – 6200 Country Club Rd., Silsbee - thermometer in reach-in cooler was broken & not recording proper temperature, dressings, milk & a container with used batter mix had no labeling of discard date, foods taken from their original packaging & stored in other containers: flour, sugar, cornmeal were not name labeled on the containers, flies were in abundance in food areas & on food contact surfaces – earned a score of 94
- Liberty Tree Coffee - 115 W. Hwy. 105, Sour Lake, TX - All specifications met- Earned a perfect score of 100.
- The Pine Knot Café - 27272 FM 787, Thicket, TX - All specifications met- Earned a perfect score of 100.
- Village Creek Coffee Company - 1180 Highway 96 S., Silsbee, TX – Earned a score of 98 – No date on opened commercially prepackaged food.

- Sonic – 135 N. LHS Dr., Lumberton, TX – Earned a score of 95 – No disposable towels at hand sink. Wet cloth being used to catch drips from strawberry pump. Product sitting on floor needs to be up 6 inches. Cleaning frequency of facility.
- Huneez Small Town Café – 300 S. Pine St., Kountze, TX – Earned a score of 99 – Food being stored outside on shelf. Outdoor storage isn't closed in.
- Boutte's Boudin - 568 North LHS Dr., Lumberton, TX – Earned a perfect score of 100.
- Yellow Rose Meat Market - 467 N LHS Dr. Ste. 104, Lumberton, TX – Earned a perfect score of 100
- Kountze Methodist Church – 1015 S. Pine St., Kountze – all specifications were met – earned a perfect score of 100
- Subway – 325 N. Main, Lumberton – all specifications were met - earned a perfect score of 100
- Quenchie's Shaved Ice – 55 West Chance Rd., Lumberton – all specifications were met – earned a perfect score of 100
- Napoli's – 835 S. Main, Lumberton - ice machine & soda machine ice spout was observed with black substance inside, food contact surfaces not being wiped with sanitizer after cleaning, no Food Manager or food Handler certifications were held by employees on duty, no hot water was observed at the hand sink and hot water temperature at the ware wash sink was not at minimum 110 F, thermometers were missing in coolers – earned a score of 89
- Tia Juanita's – 322 S. Main, Lumberton – large bulk containers holding sugar, flour & spices where not name labeled, employer did not have food handler certifications on site for employees being employed 30 days or longer – earned a score of 98
- CVS #2996 – 100 S. LHS Dr., Lumberton – all specifications were met - earned a perfect score of 100
- Burger King #134 – (re-inspection) - 112 S. LHS Dr., Lumberton – cut onions were being held out of temperature past the discard time, freezer door was not in good repair – foods were observed thawed from their frozen state, clean onion slicer & utensils were observed with food debris, floors & sides of equipment showed grease accumulation & debris under equipment – continual cleaning schedule for the establishment is necessary, hot water heater & faucet @ the utility sink area leaks & pools water on the floor – earned a score of 94
- Frontier Rodeo Coffee & Bakery – (New to Lumberton) – 133A N. LHS Dr., Lumberton - all specifications were met – earned a perfect score of 100

- Brookshire Brothers – General/Deli/Meat/Poultry - 421 S. Main, Lumberton – foods in the Deli cooler were not marked with a date to be consumed or discarded, hand washing sink was blocked & not easily accessible – earned a score of 96
- Frontier Rodeo Coffee & Bakery – (New to Lumberton) – 133A N. LHS Dr., Lumberton - all specifications were met – earned a perfect score of 100
- Tejas #3 – 620 Hwy 69 N., Kountze – the cooling time and temperatures were not being monitored on gravy being cooled for later use, no sanitizer solution was available or in use for ware washing or for sanitizing food contact surfaces, a food thermometer for properly measuring foods was not observed during the inspection, the 3 compartment sink drain pipe was leaking & the compartments in the sink were not able to hold water, fish filets were being thawed submerged in a container of water in the walk in cooler, condensation & grease were observed on & dripping from the ventilation system above the food prep cart and stove – earned a score of 88
