GENERAL DESCRIPTIONS: County proposes to do paving on roads in Precincts 1, 2, 3 and 4. Estimated square yards is approximate and payment will be for actual measured footage times price per square yard. SEE ATTACHMENT LENGTH TO BE PAVED, AND WIDTH OF ROAD TO BE CONSIDERED.

Contractor may submit a bid for all Precincts or choose one or more Precinct(s).

CONTRACTOR TO FURNISH: All materials, manpower and equipment not furnished by county, including but not limited to water, sweeping existing pavement, traffic control, furnishing/applying tack oil with 100% coverage, laying County furnished asphalt, compacting to (2) two inch thickness (unless noted otherwise in detailed specifications attached).

COUNTY TO FURNISH: Hot mix asphalt.

Contractor to commence work no more than 30 days after receiving bid, unless other arrangements are made with the Commissioner. Contactor to coordinate asphalt delivery with asphalt supplier. Contractor will notify County immediately of any delivery problems or any problems concerning asphalt.
